Should an official not provide a maintenance evaluation by December 1st, their certification Rank will be downgraded one full level at the same Category (eg 4A to 3A, 4B to 3B, etc). 1 A/B officials not providing a maintenance evaluation will be downgraded to 1C. Officials will continue to lose one level per year (to a minimum Rank of 1C) that maintenance evaluations are not provided. Extenuating circumstances for not providing said evaluation will be considered providing the same outline in writing to the respective provincial Officiating Director.
